### **Entry to Promotion**

1. Must be 21 years of age or older to participate.
2. Must be a member of the A-Play Club to participate.

### **Promotion Details**

1. Guaranteed cash drawing to be held Thursdays, Fridays, Saturdays, and Sundays in June beginning on Thursday, June 11, 2026 and completing on Sunday, June 21, 2026.
2. Must be an A-Play Club® Card member and at least 21 years of age to participate.
3. Drawing is open to all current A-Play cardholders. Guests can sign up for an A-Play account by visiting Player Services, speaking with a marketing representative or using a marketing kiosk.
4. To be eligible for the drawing, the guest must visit any marketing kiosk to activate their entry into the daily drawing. This action must be taken each participation day starting at 4:00pm-9:55pm.
5. All A-Play members receive one (1) free entry each day. There will be no earned entries for any drawing.
6. Drawings will be held between 7:00pm - 10:00pm, on Thursdays, Fridays, Saturdays, and Sundays during the two specified weekends in June, 2026.
  - a. There will be one (1) winner called every drawing session.
  - b. Winners will be announced over the intercom and will have three (3) minutes to identify themselves at the Promotion Station at The Saloon inside Primm Valley Casino.
  - c. Each draw will award a guaranteed cash prize variable upon progressive/machine type.
  - d. Guaranteed cash prize amounts will be announced to the public, per diem.
  - e. If the winner is not present after three (3) minutes of being announced, names will continue to be drawn until one (1) winner is identified.
